I am writing on behalf of the National Council to Improve Patient Safety Through Health Literacy. We request your consideration of the enclosed Council proposal. The focus is on developing a certification for health literate healthcare organizations — to recognize healthcare organizations that meet predetermined evidence-based criteria.

### **Background: The Challenge**

In 2019, the Health Literacy Committee of Greater Cleveland (Ohio) learned that many local healthcare organizations lacked awareness of health literacy as a patient safety issue. We also found that this problem exists well beyond our local jurisdiction. Failure to address health literacy at the hospital level is a challenge nationally.

However, we were aware that some healthcare systems have made health literacy an organizational priority. We believed that if these organizations were recognized through certification, it would incentivize them to sustain these efforts. Additionally, the prospect of certification could encourage other organizations to begin implementing health literacy best practices.

Seeing the potential benefits to certification, our local committee initiated a Call for Action — forming a National Council comprised of recognized health literacy experts. The Council's task is to frame the problem and solution as compelling and critical issues linking health literacy and patient safety.

### **Our Proposed Solution**

Enclosed you will find our proposal, which documents the need for certifying organizations that recognize health literacy as an institutional priority.

In the proposal you will find:

- A summary of what can occur when organizations do not address health literacy.
- Benefits of health literacy certification.
- Our evidence-based recommendations for health literacy certification.
- An appendix illustrating one organization's health literacy assessment, which highlights implementation of multiple health literacy strategies.
